### **New Business**

3. Dixie Trebbe informed us of two possible dates for the Winter LTM and Lobby Day during the 60 days of the 2013 legislative session, with Feb. 14 being the last day to enter bills. January 27-28 would be before all bills would be introduced. February 17-18 would be midway during the legislative session. This group recommends the January 27-28 dates if confirmed by the host Santa Fe branch.

### **Unfinished Business**

2. Shelley distributed four handouts for discussion:
  - A) A description of the Polling Place Participation & Protection Campaign
  - B) The workplan draft of this campaign
  - C) "Essential Information for New Mexico Voters" compiled by Count Every Vote New Mexico
  - D) A letter from Oriana Sandoval, Executive Director of New Mexico Vote Matters stating their purpose and desire to collaborate with AAUWDixie Treebe moved that AAUW-NM become a member of the Polling Place Participation & Protection Leadership Table and be willing to partner individually with any of its members during the 2012 General Election to further AAUW goals. The motion was seconded by Sylvia Fink and passed unanimously. This vote gives permission to add the AAUW-NM name to the Polling Place Participation & Leadership Table and allows Dixie to represent us and participate in the Leadership Table to gather information and disseminate it to branches so that branches and individuals can participate in election activities to get out the vote as they see fit.

### **New Business**

6. Karyl and Shelley have received a request from AAUW-Nebraska president Marilyn Bombac asking us to help them complete the Stan and Mary (Browne) Tyler Research and Public Grant Fund #1503, established in memory of Stan Browne. Mary Tyler Browne is currently our AAUW-NM Funds Chair and serves on the grants panel for AAUW Community Action Grants. She was AAUW-Nebraska President (1974-1975), was appointed to the Association Committee on Women and became its chair (1978-1980), and was elected Regional Director, Upper Midwest Region (1983-1985).

Natalie Markin moved that we adopt the AAUW-NM Funds formula approved for 2011 for the 2012-2013 AAUW-NM year, from July 2012 through June 2013. The motion was seconded by Carol Ann Council and passed unanimously. The formula is 5% at the discretion of the AAUW Funds Chair, with the remainder split 1/3 to LAF, 1/3 to NCCWSL, and 1/3 unrestricted.

Karen Nelson moved that the AAUW funds undesignated and the 5% for other funds

from AAUW-NM for July 1, 2012 through June 30, 2013, go to Fund #1503. The motion was seconded by Sylvia Fink and passed unanimously.

[At this point, Shelley had to leave and the gavel was passed to Karyl. We returned to the remaining agenda items.]

### **Approval of Appointed Officers**

Sylvia Fink moved to approve the appointed officers as listed on the 2012-2013 AAUW-New Mexico State Officers handout. The motion was seconded by Carole Ann Council and was passed. The officers are Cas Mason (Awards), Della Acosta (Diversity), Bonnie Rutherford (Historian), Mary Sandford (Mini-grant chair/immediate past president), Patricia Maben (Newsletter Editor), Carol Ann Council (Parliamentarian), Dixie Trebbe (the Lobby Corps) and Lina Germann (Web Mistress).

Appointed officers needed are Bylaws Chair, College/University Chair, International Interest Chair, Media Relations Chair, and Strategic Planning Chair.

### **New Business**

1. **Nominating Committee** Pam Daves, Deanise Marta, and Mary Sandford (Chair) have agreed to serve. Their appointment was approved.

2. **Mini-grants**

Mary Sandford (Chair), Phoebe Pierce from Las Cruces, and Enid Tidwell from Santa Fe have agreed to serve. Their appointment was approved.

Mary Sandford moved that the mini-grants offered to branches by AAUW-NM be renamed "Branch Project Grants," that the maximum amount awarded be raised from \$150 to \$200 and that Article V, section F of the AAUW-NM Policies and Procedures be amended to reflect these changes. The motion was passed.

4. **A Resolution to Eliminate Human Trafficking in Our Society**, submitted by Karyl Lyne and Mary Sandford

*WHEREAS, for over one hundred thirty years, AAUW has worked to secure educational, social, and economic equality for women and girls in American society and worldwide,*

*AND WHEREAS, AAUW recognizes that a growing problem in the United States and worldwide is the trafficking of women, girls, and boys for the purpose of sexual exploitation,*

*AND WHEREAS, human trafficking is a particularly revolting form of exploitation that exists in many communities in our society,*

*BE IT RESOLVED, that members of AAUW-NM, a part of the Rock Mountain region of AAUW, will work to publicize this problem in our communities and states, and will work with public officials and other like-minded organizations to reduced and ultimately eliminate the trafficking of persons wherever it occurs.*

Sara Wolters, AAUW-AZ President will collect a resolution from each state AAUW in the Rocky Mountain Region and send them on to National. The resolution was passed today by AAUW-NM.

**5. Medicaid Expansion under the Affordable Care Act**

Dixie read a letter from 14 organizations to Governor Martinez urging her to implement the Medicaid Expansion for low-income adults under the federal Affordable Care Act. Because of a short deadline, co-presidents Caryl and Shelley authorized Dixie to submit AAUW-NM as a signatory to the letter.
