The afternoon will feature a Women's Leadership Forum organized by Mona Wecksung. Three women leaders from different fields--business, politics, and academia, will discuss what can be done to support women as emerging leaders. There will be interaction with the group, and hopefully AAUW-NM will be able to form an Action Plan.

Dinner on Saturday evening will feature a treat and a leader of a different nature. We are fortunate to

have a talented member of the Santa Fe Branch, Patricia Jonietz, who will give her dramatic reading of the “endings” that come in a woman’s life and how they are described in literature.

On Sunday morning, we will meet once again with our Leader-on-Loan to discuss and ask questions about any matters relating to AAUW; local, national, or international. Come help us celebrate our 70th convention--and the Santa Fe Branch 70th birthday. Our program will be interesting and fun.

BYLAWS AMENDMENTS FOR THE 2003 AAUW CONVENTION

Passage of the proposed amendments requires a two-thirds vote. If a bylaws’ amendment originates from the convention floor, a unanimous vote is required for passage. The gist of the proposed amendments follow.

- **Open membership to all who support AAUW’s mission.**
- **Open membership to holders of associate degrees**
- **Establish business/organization membership category.**
- **Create position of Legal Advocacy Fund finance vice-president.**
- **Establish election of Association directors-at-large by plurality vote.**
- **Clarify composition of Association Board of Directors.**(On the restructured Association Board of

Directors only two representatives of the regional directors serve.)

- **Add a Director-at-large to Executive Committee.**
- **Establish a standing committee on International Affairs**
- **Change length of inactivity relative to forfeiture of branch status.** (This would change 12 consecutive months to 24 consecutive months.)
- **Provide regional directors with voting status at convention.**

Marion Isidoro

In the Association Convention election in June, our own Marion Isidoro is the only candidate from the Rocky Mountain Region, except for one candidate for regional director. Marion is a candidate for one of the eight positions as Educational Foundation Director.

Marion, a member of AAUW for more than 40 years, has been co-president of AAUW-NM, AAUW-NM EF chair (five years), AAUW-NM membership chair, Albuquerque branch president, vice-president and EF chair, and has attended all Association and Rocky Mountain Region conventions since 1983. She taught at mid-school, high school and university levels. For 34 years she has been a docent at the Albuquerque Museum. Marion's AAUW honors have included four named-gifts and in 1998 the Grace Barker Wilson Award.

As an EF director, Marion hopes to increase the fund-raising capability, to help members and the public become more knowledgeable about the foundation, and to bring back Career Development grants and Community Action grants.

Utah's Disability Project

AAUW-Utah was awarded a grant from funds NOD  gives annually to AAUW. The Association solicits the grant proposals. Carol Sawaya spearheaded the work of the Wasatch Branch in producing "Shrinking the Gap," a video on disabilities, and the accompanying video packet which includes "information about the NOD grant, and highlights of AAUW-Utah's accomplishments and partnerships with organizations for people with disabilities." AAUW-Utah had partnered with the Utah Advocacy Network and the Utah Independent Living Center.

AAUW-Utah's disability project has received much media recognition for its excellence. The video is available for a modest cost--call Carol Stinner 1-435-752-2658.

In November an hour-long workshop, entitled "I Can Do That," was held at Senator Orrin Hatch's 18th Annual Women's Conference. The hall where the forum was held was filled to capacity. Speakers were a paraplegic who had been an Olympic silver-medal skier, a woman who has cerebral palsy, and a woman from West Jordan who has Down Syndrome. Each woman had a remarkable success story. Salt Lake and Brigham City held disability education forums in November. "Making Connections at Mount Vernon" [Virginia]

"...Because our branch is small, our 'special attraction' is for potential new members. When the

membership Vice Presidents solicited new contacts from every member, nine joined. Information packets went to the remaining prospects and they were personally invited to other branch activities. The membership VPs keep a membership file containing details on everyone's various interests. From these files, common interest groups were determined. If either the Mt. Vernon or Alexandria Branch had activities pertinent to the interest groups, the interested people were guided to those activities. Both branches will be organizing new activities to accommodate other interest groups, and both branches are encouraging their members to participate in the other's activities as a way of strengthening our cross-branch 'connection.'

This year we sponsored a new-member 'happy-hour' orientation where people 'connected' on their way home from work. We plan to feature a new member's photo and personal sketch in the newsletter each month. At functions this helps the long-standing members "connect" with the new members more quickly...."

“Fairfax City [Virginia] Forges Link with Africa”

“When the Fairfax City Branch struggled through the process of writing its strategic plan, a few key phrases were included about incorporating an international outreach..Then in August of 2001, President Myrna Brown attended the International Federation of University Women's (IFUW) conference in Ottawa. While at the conference she met two women from Burkina Faso, who had been sponsored to attend by UNICEF. One of the women, Rasmata Barry, of the Fulani tribe, came from the small village of Kongoussi where Myrna had lived and worked over 30 years ago. Since that time, Rasmata has begun a yearlong program at the University of Quebec in Montreal to complete postgraduate work in rural development and resource management....

Importantly, Rasmata belongs to a group of very strong women, the Ougadougou, Burkina Faso Branch of IFUW. Those women are accustomed to facing the challenges dealt them through poverty, poor access to education, and the strong threads in a culture that deny women their basic rights. Among other projects, they are mounting a campaign to further decrease female circumcision through sensitizing others, working to get information into the curriculum and working with government agencies to get the current laws enforced....

The events of September 11, 2001, only reinforced the branch's desire to see broader changes for women around the world....the Fairfax City Branch saw this opportunity as the opening it wanted to work directly with another branch. Never before has the status of women around the world been so important or so relevant as it is today.”

North Carolina's Online Satellite

AAUW in Winston-Salem has established the North Carolina Online Satellite, which welcomes “all who wish to participate in an AAUW group that meets online rather than in person.” The branch points out that this “can provide the local touch” that is lacking for members-at-large, and that this is also a way for members of other branches to expand involvement in AAUW, especially by reaching members who find it difficult to get to branch meetings.

Online Satellite members are sent the Winston-Salem newsletter and yearbook and can participate in the e-mail list discussions. To join, members of other branches pay Winston-Salem dues, while members-at-large pay both AAUW-NC and Winston-Salem dues.

Winston-Salem Branch has found the response very encouraging--like entering “a new era with

AAUW.”

PAY INEQUITY

Two Pay Equity bills are in the state legislature: HB 325 “The Equal Pay Task Force”, carried by Rep. Rhonda King (similar to the bill carried last year by Rep. Mimi Stewart, which passed but was vetoed by the Governor), and HB 41, carried by Rep. Al Parks “Prohibiting Wage Discrimination Based on Gender”. The latter bill would provide enforcement and civil remedies up to three times the lost wages.

Numerous studies, for example, Census Bureau data and industrial studies, have verified the existence of pay inequities for women. Below are some of the facts.

- _ Currently, women working full-time and year round receive 73 cents on the dollar compared to men. African American women receive 65% and Hispanic women only 52%.
- _ With reference to age, experience, education, motivation, choice of profession, etc., the wage gap persists, with variables accounting for only about 1/4 to 1/2 the wage gap.
- _ Women holding the same jobs as men, with the same age, experience, merit,, etc, STILL make less than men.
- _ A 2001 study showed that 65% of teenage girls still earn minimum wage, while only 36% of the boys do.
- _ For retirees, the income gap for women is 56% of that for men.
- _ The typical 25-year-old woman with a college degree will made \$500,000 less than men in wages over her lifetime. This will affect her retirement income.
- _ For one in four retired women, Social Security is the only source of income.

AAUW, BPW, and AFLCIO surveys show that 90% or more of women rank pay equity a top personal and political priority.

AAUW was instrumental in forming the New Mexico Pay Equity Coalition. Other coalition members include Business and Professional Women, MANA, Hadassah, AFLCIO. NOW, New Mexico Commission on the Status of Women, UNM Women’s Resource Center.

The Bare Bones Budget Coalition has recently completed its survey of the actual minimal subsistence living costs in cities throughout New Mexico. After economists have compiled the data, the report will be released. The data will substantiate that actual cost of living in poverty here is more than the “Federal Poverty Level.”

LAF Project: Assisting Women Faculty Members in New Mexico

The LAF team, Mona Wecksung and Jan Bray, have been traveling around the state meeting with New Mexico college and university faculty women and AAUW branch women. In Las Cruces our team, AAUW-NM president Carol Ann Council, and Las Cruces Branch president Ruth Benjamin met with three NMSU professors, Laura Huenneke, Lisa Frehill, and Tara Gray, who have been very active in addressing women’s issues on campus.

The NMSU professors asked for AAUW assistance in three areas:

1. To build a communication network connecting faculty women of all New Mexico universities and colleges, to serve as a statewide forum through which faculty women can discuss issues, seek support, and send out information
2. To locate women with strong leadership positions in New Mexico who will address women faculty and graduate students on assuming leadership roles in our society

3. To locate professionals on assertiveness training to present workshops on campus

We have been working on all three of these requests. Our biggest problem is finding someone to present assertive workshops. Any leads? We would be most appreciative.

In Roswell I met with ENMU faculty member Marian Matthews. Marian has been a panel member on women's issues at two of our AAUW-NM meetings and is in desperate need of support. The main ENMU campus is in Portales. To help Marian and others at ENMU it is very important that we develop strong support for them in Eastern New Mexico. The Carlsbad Branch has volunteered to help, and one of its members, Shila Marek, joined us at this meeting. Two issues where AAUW could help emerged from this meeting:

1. Childcare has always been a major concern. A number of these women work at night when no child care facilities are open.
2. Hispanic women of Eastern New Mexico lack power, and need help in assertiveness and organizational skills.

About donations, according to the LAF national office, New Mexico's contributions to LAF for 2002 are down 30% from 2001. . Albuquerque, Grant County, Las Cruces, Raton, and Santa Fe gave less in '02 than in '01. AAUW-NM (\$590.00 in '01, \$740.00 in '02), Carlsbad, Las Vegas, Los Alamos, San Juan County, and West Mesa gave more in '02 than '01. Portales gave the same amount both years. The complete totals: \$3,766.00 in '01 and \$2,622.00 in '02. Let's work on this!

Carol Mandell, Professor of Veterinary Medicine, in speaking at our AAUW-NM Convention last year, told us about her being denied tenure in favor of a much-less qualified male, and its aftermath. She sued the University of California-Davis School of Veterinary Medicine for sex, age, and national origin discrimination. The court has made a tentative ruling on her motion for summary judgment supporting her on gender and age discrimination, but dismissing her claim of national-origin discrimination. The trial will begin in March. LAF has contributed funds to her case.

□ □ LOBBYING THE LEGISLATURE □ □

Much is going on the in the New Mexico Legislature. As of January 31, there were more than 200 bills on education alone.

The redo of last year's Education Reform Act (carried by Rep. Stewart, D-Bernalillo and Sen. Nava, D-Dona Ana) has been introduced into both houses. It includes the three-tier licensing system for teachers, and raises the minimum pay to \$30,000. The bill will phase in the three-tier system, expecting in five or so years to cover the most highly qualified teachers with the most experience at a \$50,000 salary. The bills also meet the requirements of the Federal "No Child Left Behind" Act, and the reforms recommended by the LESC and the LESC Ad Hoc Subcommittee on Education Reform. It contains criterion-based tests (versus norm-based) in the schools. It includes the mentoring program for new teachers. It appropriates approximately \$11,700,000 million for these reforms.

The enrollment growth issue is covered by HB 109 (Rep. Swisstack, D-Rio Rancho) and SB 231 (Sen. Nava, D-Dona Ana). We have supported this issue--the bills will phase in the effort because there is not enough money to do all of the enrollment growth changes in this fiscal year. In 2001 I was on the AT Risk

Factors and Enrollment Growth Task Force which considered this issue.

On the Charter School issue, Rep. Gonzales (D-Taos) has introduced HB-375 which contains the recommendation of the LESC Subcommittee on Charter Schools. Sen. Romero (D-Bernalillo) has introduced a bill to allow charter schools to exist for 15 years (versus the current five years) without reapplying.

A bill to fund the mentoring program for new teachers was introduced by Sen. Papen (D-Dona Ana). There are bills to complete the funding of full-day kindergartens.

Bills concerning capital outlay, based on the recommendations of the Capital Outlay Task Force, will be high cost and are intended to satisfy the “adequacy” requirement of the judge’s ruling in the Zuni suit. As of January 20, there were at least five, and the bill on funding educational technology was not yet written.

AAUW-NM’s retired teachers who are in the ERA, consider this! The LESC has requested a study (to be completed by November, 2003)--HJM 2, carried by Rep. Heaton (D-Carlsbad) on combining the PERA and ERA retirement systems.

Resolutions, if approved by both houses, will go to the voters in November, 2003. Those proposed include several to allow the Governor to appoint a Cabinet Secretary for Education, with provision for either abolishing the State Board of Education or changing its composition and responsibility to make it only advisory. AAUW HAS STRONGLY SUPPORTED THE RETENTION OF THE STATE BOARD OF EDUCATION IN ITS PRESENT CONFIGURATION. WE ARE VERY CONCERNED WITH A “FLIP-FLOP” of educational philosophy every time the New Mexico state administration changes. To this end, the League of Women Voters of New Mexico and AAUW-NM sent a letter to every legislator explaining our position on retention of the State Board in its current responsibilities. Each branch president also received a copy of the letter. **Another important set of resolutions covers the use of interest from the Permanent Fund**, to provide more money for education. At present there are resolutions to raise this from 4.7% (the figure in the Enabling Act of 1910) to 5%, 5.5% and higher. AAUW-NM has been supporting a change to 6%.

The Partners in Education, of which AAUW-NM is a member, published their 2003 consensus document, detailing the philosophy and areas of Partners support. I testified for the Partners and for AAUW on education issues before the House Education Committee on January 31. Partners held a press conference in the Rotunda on February 3. Copies of the consensus document have been provided to every branch president..

I could go on forever.....but there isn’t space in the *Roadrunner*. Watch the newspapers and other media to keep up!

The Choice rally was held at the Roundhouse at noon on January 22--the 30th anniversary of the Supreme Court’s Roe v. Wade decision. Rep Tom Udall (D- 3rd Congressional District) addressed the rally-goers, The rally was followed by a press conference. Senators Cisco McSorley and Dede Feldman addressed the group, as did members of the Coalition for Choice. In the evening about 200 people attended a fund-raising dinner for Choice.

Anti-Choice bills in this legislative session include ”Parental Notification,” introduced as follows: HB 344 (Rep. Regensberg, D-Dist. 68); HB 328 (Rep. Larranga, R-Dist. 27); SB 309, (Sen. Griego, D-Dist. 39). All require parental notification before a minor could get an abortion. Judicial bypass is included.

Defining life and death and when life begins are the topics of two more worrisome Joint Resolutions. SJR

7 (Sen. Komandina, R-Dist. 9), is entitled “Define ‘Life’ and ‘Death,’” and SJR 8 (Sen. Sharer, R-Dist. 1), is entitled “Define When Life Begins.” Both of these, if passed, would go to the voters in November. Both would make **the concept of Choice--a woman’s right to decide within her own ethical framework--**moot because of the definition of when life begins.

Two bills that would provide for rape victims have been introduced. Rep Gail Beam (D-Dist. 18) introduced HB 315, “The Emergency Contraception Act,” which would require hospital emergency rooms to provide emergency contraception (the “morning after pill”) to rape victims. Quite a few of the emergency rooms around the state already provide this, but many others do not. Rep. Stewart (D-Dist. 18) introduced HB 119, the “Sexual Assault Survivor’s Emergency Care.”

Several other bills supporting Choice have also been introduced. Since bills can still be introduced, there may be more on Choice and anti-Choice.

CAMPAIGN REFORM

New Mexicans for Campaign Reform (NMCR, AAUW is a member) is working hard to get the New Mexico legislature to pass a **pilot bill for voluntary public funding for the Public Regulation Commission (PRC) which is the most powerful commission in our state.** By law PRC regulates almost everything from utilities to insurance, to transportation, etc., affecting us all.

There will also be a bill for voluntary public funding of the other elective state offices that has not yet been introduced. NMCR does not have much hope for it this time around since the Governor opposes public funding for campaigns.

Three members of the PRC, two Democrats and one Republican spoke in favor of voluntary public funding at the press conference on our Legislative Day in Santa Fe on Jan. 27th.

Bills important to campaign reform introduced at this time are:

- ◆ **SB 222** (PRC bill) sponsored by Senators. Dede Feldman and Manny Aragon with committee assignments to Rules (it passed Rules on Feb. 12), then Finance.
- **SB 22** (electronic filing) sponsored by Senator Dede Feldman.
- ◆ **HB 420** (PRC bill) sponsored by House Speaker Ben Lujan with committee assignments to Voters and Elections (passed Feb. 11), the Judiciary, then Appropriations and Finance.

AAUW members need to write, phone or e-mail their Senators and Representatives in support of these bills. Since the bills do not affect their offices there is a good chance legislators will support them. When one of these bills reaches the Governor's desk we will all need to contact him and ask him to please sign it into law.

Voluntary public funding of campaigns is important to our democracy to help restore citizens' confidence in their elected officials, and to level the playing field for candidates and allow them to concentrate on the issues.

LEGISLATIVE VOTER ALERT

HB 310 (Rep. Stewart, D-Bernalillo) was introduced to set a date for a Special Election to bring the constitutional amendments, resulting from Resolutions in this Legislative session, to the voters. The bill was amended by the HAFC to provide a date of November 4, 2003, for this election. As amended, HB 310 received a Do Pass from the committee.

The amendments will include several education issues of interest to AAUW-NM. One would increase the amount of interest received from the Permanent Fund to provide more money for education. Other resolutions cover the issue of a cabinet-level position for education and the role/function of the State Board of Education. AAUW is supporting no change in the Board's responsibilities.

With November 4th set for the election, we are asking all AAUW branches to consider the constitutional amendments at their October meetings. We will provide a list of the amendments and information at the AAUW-NM Convention.

CRISIS LOOMS IN EDUCATION

AAUW-NM **supports** the present governance policy for education in New Mexico, and **opposes** any changes in this policy. The structure as it exists now consists of a fifteen member State Board of Education (SBE), ten of whom are elected by New Mexico districts with an additional five members appointed by the governor. The SBE has the authority, along with the legislature, to control educational policies and funding. The SBE currently hires the State Superintendent of Schools.

Critics may tell you that the governor is responsible now for policies he does not control. We beg to differ on this position for the following reasons:

AAUW-NM feels that any change in the present structure gives additional focus to special interests, and on partisan politics. A change takes control away from the public which now has oversight by a direct control of the electorate. A change in structure could remove education policy-making even further away from the best practices of the educational community, a movement that began some 30 years ago with, some would say, the disastrous results seen in today's schools.

Any change in governance would require a constitutional amendment and a "yes" vote from New Mexico citizens. The governor has said an election could be held in November. Please communicate to legislators, as well as members of the public, that AAUW-NM does not favor any plan to decrease, or eliminate, the 15 member State Board of Education.
