Finally, we spent a very active and animated hour in small groups discussing and discerning public policy priorities for the next year for AAUW-NM. It was an exciting, purposeful and affirming exercise from which we will determine how our lobbying time and energies will be spent this year.

Now we're looking forward to the Fall LTM and Workshop in Albuquerque on Saturday, October 12, at the First Congregational Church at 2801 Lomas Blvd NE. We will begin at 10:00am (so folks can attend the balloon fiesta if they wish and/or so out-of-towners can drive up that morning). Then we'll have lunch and hear from the young women who attended NCCWSL in May in Washington, D.C. Their insights and experiences are always inspiring. We look forward to working with each of you this year and especially leading up to and during the 30-day legislative session that will begin January 21 and end February 20. Her expertise and experience helped make a real difference, and we appreciate all of her

We will focus on 3 key areas during the coming year: Education; Finance; and Women's issues. We want to reinvigorate the Lobby Corps and ask that each branch provide at least one member to work with us not only as Public Policy representatives but also to serve in the Lobby Corps. Dixie has already agreed to focus her efforts on women's issues. She will stay abreast of what is happening in the state and the legislature and try to attend pertinent committee meetings. We are seeking individuals that are interested in focusing on and keeping up with the other two areas.

There are several tools to help all members keep up with what is happening in public policy both at the state and national level. Lina has been working very hard on our new state AAUW website and has done a superb job. It is still in the developmental stage, but is already filled with many resources. # **Branch Project Grants**

AAUW-NM budgeted \$600 to be used for grants to branches during the fiscal year of 2013-14. These grants are intended to help the branch finance projects that advance the mission of AAUW. The only requirement for a branch project grant is that the project must have an outreach, educational or mentoring component. While new programs will be given special consideration, established projects are also eligible.

**The maximum amount** that can be requested by a branch is **\$200**. Please understand that a branch may ask for **LESS** than \$200! Also, if there are several worthy projects submitted, a branch may not receive the full amount requested.

**Applications** for the Branch Project Grants **are due to Mary Sandford no later than October 1**st. A committee will review the applications and the grants will be awarded at the Fall Workshop in Albuquerque on October 12th. There is no formal application form; the instructions are in the AAUW-NM Policies and Procedures, Article V, section F. The Policies and Procedures are on the AAUW-NM website under "Governance and Forms." It is preferred that the applications be submitted electronically, but snail mail requests will certainly be accepted.

Please consider requesting a "Branch Project Grant" to aid your branch in advancing the goals of AAUW!
