Directions to Santa Fe Skies RV Park:

Coming north on I-25 from Albuquerque, take exit 276A. Turn right at the bottom of the off ramp. Proceed straight through the stoplight at NM Hwy 14, going past the Allsup's/Phillips 66, which will be on your right. Santa Fe Skies RV Park is about ½ mile up the road on the left.

Coming south from Las Vegas, take the 276A exit from I-25. Turn left under I-25 and continue to the stoplight as mentioned above.

From downtown Santa Fe, travel south on Cerrillos crossing under I-25 until you get to the traffic light at the Allsup's/Phillips 66 gas station. Take a left at the light and go up the hill about ½ mile. Santa Fe Skies is on the left at the top of the hill.

I think I can speak for everyone at the Fall LTM in Rio Rancho when I say that we were pleased, impressed and invigorated by the poise, eloquence, enthusiasm and variety with which “our” NCCWSL scholarship recipients spoke about their experiences at and ‘take aways’ from the National Conference for College Women Student Leaders in Washington, DC, in June, 2011. As you all know, AAUW-NM provides the registration (\$395) for three New Mexico women to attend NCCWSL. This year Yolanda Patterson from Central New Mexico Community College, Michaela Rempkowski from New Mexico Tech and Serina Allingham from New Mexico Highlands University were our three recipients. In addition to the AAUW-NM support, each of them received \$100 from the Las Vegas Branch and Michaela received support from the Socorro Branch and Yolanda received support from the Albuquerque Branch. It would be great if every branch would put a line in the budget to support the NCCWSL recipients.

Yolanda, a sophomore in Health Information Technology, talked with particular poignancy about her experience at a DC homeless shelter, one of the pre-conference activities. Michaela, a chemical engineering major, shared her experience of being one of three women of the 500+ at the conference who showed up for a workshop for women in the STEM fields, and how that underscored her determination to work with girls to encourage them to go into science, technology, engineering and math. Serina, a recent graduate from NMHU in business/accounting, expressed her delight at meeting so many women who shared her ideas about personal empowerment and leadership, and who had accomplished so much already in their lives. Each of the women talked about how much the conference had broadened their perspectives on themselves and what they could do with their lives and careers. All described the conference as life changing and expressed their gratitude to AAUW-NM for its financial support.

NCCWSL is one of the many wonderful programs AAUW offers young women of New Mexico and it is a talking point as we recruit New Mexico colleges and universities to become AAUW institutional partners. The NCCWSL Scholarship Application Form is on the AAUW-NM website (aauw-nm.org) and it is not too soon to begin to encourage collegiate women you know to apply. The deadline for applications is March 15, 2012. I want to express my appreciation to the scholarship recipient selection committee of Adrienne Dare from Silver City, Maryjane Geisler from Los Alamos, and Meta Levister from Las Vegas. Let’s make their job as hard as possible with lots of wonderful applicants for NCCWSL 2012!

Start Smart Takes Off in New Mexico

The first Start Smart workshop in New Mexico was held in Los Alamos on November 4. We had six current students and twelve non-student adults (AAUW members and UNM-LA faculty and graduates) participate, and all had fun and learned a lot. Some of the AAUW members, who I hope will all become facilitators (I'm currently the only one), also represented Highlands University, Eastern New Mexico University and NMSU-Carlsbad; all schools where we hope to hold future workshops. Thanks to the personal efforts of Nina Thayer, the support of the Los Alamos Branch and the commitment of the campus director, Dr. Cedric Page, Phi Theta Kappa and the chapter's advisor Maryjane Giesler, the UNM-Los Alamos campus has purchased a three-year license that allows unlimited workshops on campus. We plan to hold another

workshop there in late March 2012.

I also presented an overview of Start Smart at our State Fall Workshop on October 15 in Rio Rancho and at a meeting of the Santa Fe Branch on November 5. I will present an overview at a Las Vegas Branch meeting on January 21. All of this is very exciting (in my humble opinion); a way for AAUW to personally touch many young people in the state of New Mexico. Thanks go also to my state committee (Sylvia Fink, Karyl Lyne, Roxanne Lara, Nina Thayer, Sue Bracksieck, Janet Lincoln, and Natalie Markin) for their help in furthering the program. If you're not familiar with the program, Start Smart consists of 3-hour workshops which are designed to provide college and university students with the knowledge and skills to negotiate salaries and benefits so that they receive fair and realistic compensation when they enter the job market. We know that women make only 77% of what men make (on average). Failing to negotiate properly on her very first job out of college can cost a woman over **a million dollars** over the course of her lifetime. The Start Smart program is jointly sponsored by AAUW (www.aauw.org) and The WAGE Project (www.wageproject.org) on the national level.

AAUW FUNDS AT WORK

"Crossing the Line: Sexual Harassment at School", AAUW's new research report on sexual harassment in middle and high schools, was released online on November 7. It received significant media attention from a number of outlets including the Associated Press and the New York Times. This report — the first of its kind in 10 years — provides valuable information for all of us who are concerned about the next generation. Research was funded through the Eleanor Roosevelt Fund. **Articles appeared in the Santa Fe and Albuquerque newspapers.**

"More Women Study Sciences" An Albuquerque Journal (10/23/11) article about STEM (Science, Technology, Engineering, Math) stated "A recent report from the American Association of University Women notes that 30 years ago, the ratio of seventh and eighth -grade boys who scored more than 700 on the SAT math exam, compared to girls, was 13 to 1. Now it is 3 to 1."

Sara Otto-Diniz founded Art in the School in 1985. “The mission then as now was to develop a holistic curriculum for students to explore art history, criticism, aesthetics and basic art-making techniques and tools.” (Albuquerque Journal June 2011) Her first grant was from AAUW. Thank you, Marion Isodoro for this! Let us know your “**Funds Stories**”!

NM Educational Retirement Board Seeks Input on Solvency Plans

The Educational Retirement fund in NM has found itself in increasingly dire straits for several years, especially since the economic downturn of 2008. In order to ensure the fund's solvency for the future, the NMERB has developed six (6) possible options for change that will be put before the 2012 Legislature for consideration. Some of these options are not equitable or just, as they include no future COLA increases for current, let alone future, retirees, regardless of how general economic conditions change over time.

The NMERB is seeking public input about its proposed plans, both from educators affected by the proposed changes, as well as the general public. Go to www.nmerb.org to review the proposed plans, and to offer your comments. Your input can have an impact in possibly modifying whatever proposal(s) the upcoming Legislature will consider making into law. Please make your thoughts known -- the sooner, the better.

Your thoughtful input and action can make a difference on this critical statewide issue.

Directions to Joe's Pasta House (3201 Southern Blvd., Rio Rancho; 505-892-3333)

Coming from the north: Get off I-25 at Exit 242 (the Bernalillo/Corrales/Rio Rancho exit). It is Hwy 550. Turn right and go through the town of Bernalillo and past the Casino. Get in the left turn lane and take Hwy 528 (left turn going south) to Rio Rancho. After about 8 miles, turn right at Southern Blvd. Then follow the directions in the second paragraph below.

From the south: From Coors, turn left onto Alameda (Hwy 528). or get off I-25 at the Hwy 528/ Alameda exit (just north of Paso del Norte). Turn left and follow Hwy 528 into Rio Rancho. After you pass Intel get in the left turn lane and turn left at Southern Blvd.

The intersection of 528 and Southern has a large Smith's grocery on southeast corner, CVS on the southwest corner and a Walgreens Pharmacy on the northwest corner. As you go west (away from the mountains) on Southern, stay in the right hand lane and go past the stoplight by the post office. You can take either the second or third driveway (past the light) into the shopping center. There is plenty of parking.

College/University Connection---2011-2012 Fee \$130



Why should a college or university become an AAUW Partner Member institution? Let me count the reasons! First, ALL undergraduate students attending C/U partner member schools can become E-Student Affiliate members of AAUW FREE and receive access to AAUW information, research, advocacy, newsletters and scholarships. Second, AAUW Partner Member institutions receive priority access to Leadership Programs such as Elect Her, \$tart \$mart, Campus Action Project Grants, Legal Advocacy Fund Campus Outreach Grants, NCCWSL and Student Advisory Council participation. Third, each partner membership includes two faculty/staff members as C/U Representatives. Fourth, this year—AAUW's 130th Anniversary— colleges and universities who have not been members for the past two years can join for only \$130. Usually, the partner membership fee ranges between \$125 and \$350, depending on the number of full-time enrolled students at the institution.

Now is the time for us to recruit all of the institutions of higher education in New Mexico. As of 11-3-11 there are three partner institutions: New Mexico Highlands University, New Mexico Tech, and Western New Mexico University. UNM-Los Alamos has been a partner, but is not currently listed in the membership database. It would be wonderful if we could be sure UNM-LA is current with their membership fees, and recruit UNM, NMSU and Central New Mexico Community College now with

the \$130 partner membership fee break. Are there AAUWans in Albuquerque and Las Cruces who can begin this work? Please let me know who you are.

New Mexico has 23 junior/community colleges, 8 four-year public institutions and 3 private higher education institutions with campuses in New Mexico. If you have contacts at any of the two or four year colleges or universities in New Mexico and would talk with them about the benefits of being an AAUW partner member, it would be great. If you would like to help recruit college or university partner members, but don't have a contact on campus, you might talk with the president, the vice president for student affairs, dean of students, director of the women's studies program or center, faculty members in the STEM fields or the director of the career center or the director of student activities. Of course, please contact me, Karyl Lyne, at lyne@desertgate.com and we'll work together on recruiting the institution.

Opportunities to Increase Branch Membership

AAUW National has announced new membership incentives for the 130th Anniversary. For this membership year we can recruit graduate students with national dues of only \$18.81. The usual cost is \$49. This is a \$30.19 savings for their first year of membership!
