Co- President's Letter

Our AAUW New Mexico Members are amazing! Amid all the preprimary screaming among candidates our members rolled up their sleeves and opened their pocketbooks to get things done for women and girls in New Mexico! Thank you for all you do for AAUW.

Our members donated more than \$18K to Tech Trek NM and we have invited 60 7th grade girls from all over the state to participate at New Mexico Tech in Socorro June 19-25, 2016. Cheri Burch (Albuquerque and Online) is camp director supported by Karyl, Helena, Claudia Poglitsch and Jan Bandrofchak (Albuquerque), and Mary Rita Chapman and Bonnie Schranz (Las Cruces). Thank you to the Branch volunteers who called all the middle schools in the state to confirm science teacher names and e-mail addresses (a record number of schools submitted nominations), the branch volunteers who interviewed 122 girls who applied for camp, and the 23 essay readers who read and scored the application essays. We invite AAUW members to apply to be dorm Mothers for the week or to volunteer to work for a day or two at camp.

We regret to inform you that Florence Ruth Brown who has hosted the Winter LTM and Lobby Corps meeting during the state legislative session at her RV Park in Santa Fe, NM for many years passed away April 4, 2016. See the article later in this issue.

And our beloved Co-Public Policy Chair Dixie Trebbe is leaving fair New Mexico to live near family in Iowa. Dixie was mentioned in the Congressional Record April 14, 2016 in the House Extension Remarks by Hon. Ben Ray Lujan. See the remarks later in this issue. Dixie as a champion of issues that face our community, and new volunteers know her as a role model." Nina Thayer (Los Alamos) has agreed to complete Dixie's term, but we need two members to understudy Sonya Berg and Nina during the 2017 legislative session and step into the role of Co-Public Policy Chairs in 2017-2019.

Ruth Benjamins and the nominating committee were able to create an excellent slate of officers. Being on a nominating committee takes patience and fortitude. Thank you for your work on this important process. Thank you also to the members that agreed to serve on the leadership team.

* Mr. BEN RAY LUJÁN of New Mexico. Mr. Speaker, I rise today to recognize and congratulate Ms. Dixie Trebbe, a tireless volunteer, a fierce leader, and a passionate advocate. She has always been involved in the political process and encouraged others to participate and exercise their fundamental right to vote. Dixie is also on the American Association of University Women's National Public Policy Committee, the New Mexico NOW State Board, and the New Mexico Capital City Task Force for the AARP, and she is active with the American Legion Auxiliary and the Veterans of Foreign Wars.

- New Mexico's legislators know Dixie as a passionate champion of issues that face our community, and new volunteers know her as a role model. As an octogenarian, Dixie sets an example for all generations, showing us what real service is and what commitment to justice can accomplish.
- Dixie will be leaving New Mexico to live with her children in Iowa, and while we are sorry to see her go, New Mexico's loss will surely be Iowa's gain. Dixie, thank you for your service.

FlorenceRuth Jones (Flossie)



AAUW-NM and the state of New Mexico lost one of its most interesting and successful women. FlorenceRuth Jones (Flossie) died on April 4, 2016. Flossie was born in Chicago. Her family homesteaded near Santa Fe in 1935. She graduated from the Loretto Academy in 1947 and the UNM Law School in 1953. In law school she ran unsuccessfully for Albuquerque City Commissioner against Clyde Tingley at the urging of the Toastmasters. The goal was to the public accustomed to the idea of women candidates. She lost the campaign. She married

Herb Brown in October 1954. Together they owned and operated Brown Wrecking and Salvage in the 60's. She became the Chief Attorney for the Child Support Enforcement program in 1976. In 1978 she transferred to Health and Environment and became the General Counsel. Her husband Herb passed away in 1984 and in 1989 she married Richard Folmar. She retired from the New Mexico Health Department in 1991 and was the first recipient (1996) of the State Bar's Public Lawyer Award for Distinguished Service. At the LTM in Santa Fe in January she proudly talked about being the longest living licensed attorney in New Mexico (62 years).

On March 12, 2016 the Southwest Women's Law Center honored Florenceruth (Flossie) Jones Brown, J.D. for her life long contributions in the legal field in New Mexico at a banquet "Celebrating Women's Stories".

Flossie was a strong supporter of AAUW-NM. That support will continue after her death. She reminded us each year recently that she had left directions to her family in her will to allow the Winter LTM to be held at the family's business, Santa Fe Skies RV Park.

AFGAN WOMEN'S WRITING PROJECT (AWWP)

The AWWP was founded in 2009 to give Afghan women their human right to voice their story. The empowerment of Afghanistan's women creates possibilities for economic independence and instills leadership abilities as it reinforces freedom of speech. The goal of the organization is to nurture, educate, and carry the voices of Afghanistan's women to the world, while giving readers unique insights into Afghan culture.
