Ruth Benjamins, AAUW-LC President from 2002-

2004, died at age 95 in Henderson, NV in Sept. 2022. She also served as Treasurer for 3 years, Public Policy Chair for 6 years, and one year each as parliamentarian, academic chair and bylaws chair. She also served the AAUW NM board as Finance Chair for 5 years. She also actively participated in AAUW interest groups: Anything Goes, International Gourmet, Going Placed and bridge. When she moved to Nevada in 2017 she asked a contribution be made to Tech Trek as she strongly supported STEM for gils as she had received a M.S. degree from the Univ. of Michigan.

<u>Dr. Mary Berry</u>, coordinator of AAUW LC brach Teen Esteem, 1988-1990. She chaired the NM Legal Advocacy Fund 1993-1995 and served as AAUW NM President

1995-1997. She suffered a stroke in August 2023 and dies 4 days later at an El Paso hospital. She was Dean of Education at NM Adult Correctional System in Las Cruces 1984-1988; coordinator of secondary student teaching NMSU 1988-1990; administrative assistant to dean of the College of Education, 1990-1993; director of Public school administration internship program, 1994-1997; director vocationaltechnical in-service in the College of Agriculture and Home Economics, 1995-1996; director new student orientation, and Statistical analyst El Paso (Texas) C C., 1993-1995. Dr. Berry earned her PhD at New Mexico State University 1993. In addition, to her academic work, she served as Deputy voting registrar Dona Ana County, Las Cruces, and on the Board of directors of Butterfield Park Mutual Domestic Water Association. Mary was named Corrections Education Teacher of the Year, State of New Mexico, 1985, and Distinguished New Mexico Woman New Mexico Governor, Gary Johnson, in 1997.

# **CO-PRESIDENTS MESSAGE**

## Our Next Leadership Team Meeting will be on Sunday, Oct. 22, 2023 from 1:00-4:00 p.m. via Zoom

# We participated on Sept. 18th with AAUW national's leadership on our Southwest Regional meeting via zoom.

We reviewed the many issues confronting many states on how to best restructure AAUW at both the state and branch levels. What is the state's key function, what best practices do branches exemplify, how often do boards and branches meet, do you have fundraising events, do you have interest groups, how do you recruit younger members, how do you get more applicants for leadership positions, and what age groups do branches appeal to: under 30, 30-50, over 50?

#### The AAUW NM Restructuring Task Force

followed the Regional meeting the next day. We met a second time on Sept. 19th to review these and all other recommendations we received from branches' input. We also agreed on a group of 4 to collate and prioritize all recommendations for further approval at our next large task force meeting. Final recommendations will be made to the AAUW NM membership at a later date for final approval and vote. Please know our task force has 17 active members from around the state which includes Lynn and Helena and Kathie Davis who takes diligent notes on our meetings.

#### **Banned Books**

We have noted that the assault on books is an ongoing battle in many states and that AAUW CA is holding seminars on this issue. We took a look at our own history in NM; here's a short list. In May 1968, The Catcher in the Rye by

J.D. Salinger, was asked to be banned in an Albuquerque public high school by a church pastor, but the school board did not honor his request. In 1982, the Merriam Webster Collegiate Dictionary was removed from Carlsbad classrooms because it defines "obscene" words. Harry Potter and the Sorcerer's Stone by J. K. Rowling, was burned in Alamogordo, NM in 2001 outside Christ Community Church because the Potter series is "a masterpiece of Satanic deception." (In 2003 in Arkansas, the school board's decision to restrict access to the Harry Potter books was found to violate the First Amendment). In 2022-23, Florida removed 300 titles from schools and libraries. You can find the 12-page list of these online. In April 2023, Rio Rancho residents pleaded with the city council to ban books that they find offensive from the public library. At least three of the titles dealt with LGBTQ+ themes and conservatives argued against children's access to books about sexuality. After weeks of public debate, where speakers mostly denounced book banning and supported the libraries, the city council passed a resolution in support of the Library and Information Services Department. Thus to date, no books banned there.

#### **Honoring Women**

On October 2, 2023, the United States Postal Service will release a new Forever stamp commemorating the legacy of the late **Supreme Court Justice Ruth Bader Ginsburg** and celebrating her groundbreaking contributions to justice, gender equality and the rule of law. The USPS noted Ginsburg's legacy of fighting for equal rights, including her "important majority opinions advancing equality and strong dissents on socially controversial rulings."

The American Women Quarters Program is a four-year program started in 2022 that celebrates the accomplishments and contributions made by women of the United States by featuring their head on the US quarter opposite the George Washington side. Featured are women from a variety of fields, including, civil rights, abolition, government, humanities, science, space, and the arts. The women honored will be from ethnically, racially, and geographically diverse backgrounds. NM suffrage leader **Nina Otero-Warren** was honored in 2022. Jovita Idar, Mexican-American journalist, activist, teacher, and suffragist was born in 1885 and honored Sept. 15th, 2023.



# Election Time! USE the Vote411.org Resource

New Mexico's Local Election candidates have filed. Ballot questions have been determined. Early voting begins on October 10. Election Day is November 7.

This year, the League of Women Voters of New Mexico is sending invitations to all candidates across the state to participate in Vote411.org. This major effort should make it extremely easy for voters to check who is on their customized ballots and what they stand for. New Mexico just enacted laws to close schools each Election Day and to expand voter registration, absentee voting, and polling options. The site also links to voter registration information and other information of every Secretary of State. Spread the word and help make sure that voting becomes a habit here each November and across the land each general election cycle in even-numbered years. # AAUW-NM PUBLIC POLICY REPORT



What a difference it makes to live in a state that has good civil rights protections and ample financial, environmental, and human

resources! As I work with other State Public Policy Chairs across the country, I frequently and proudly share our legislation and judicial successes. However, we still have enormous challenges to overcome in order to advance equity and opportunity and to improve our quality of life.

In terms of the budget and the makeup of our government officials, there has never been a better time to advocate for AAUW priorities. In 2023, our legislature accomplished amazing feats, thanks in large part to the leadership of women, who are in the majority in our House and in key positions in our Senate. They are courageous, collaborative, community-minded, and committed and work well with our governor. NM had the largest state and federal revenues ever, and our female legislators authored and passed many measures aligned with our major priorities.

## **Educational Improvements**

In other columns, you have heard about the Opportunity Scholarships, free meals in schools, money for early childhood education and childcare, scholarships and loans for service in high need areas. We will cover these initiatives, structured literacy, and much more in future issues. This time I want to focus on our successful advocacy for financial literacy and a promising response to our call to action about our students' lack of math and science proficiency.

In 2021 and 2022, AAUW-NM participated in the updating of PED's revised social studies academic and content performance standards. For years, we pushed for financial literacy to be a graduation requirement. While a standalone course was not adopted, we are pleased to see that there are now 33 distinct personal financial literacy standards included in the final version of the new social studies standards (6.29.11 NMAC). The financial literacy standards are embedded into performance standards of social studies courses across all grades, and educators are being trained on how to teach personal financial literacy academic content and how to access free high-quality classroom resources.

At long last, New Mexico is committed to improving math and science achievement. PED and the LESC are partnering with other organizations on strategies to improve math and science teacher education and instructional support for students. Part of the urgency stems from the fact that the state has not made enough progress fulfilling the requirements of the 2017 Yazzie-Martinez court decree. We are last or close to last in math and science achievement, which we know are essential to accessing career opportunities in STEM and other fields. With NM Attorney General, Raul Torrez taking over the management of the Yazzie-Martinez suit, we hope to see state and local agencies make better progress than they have in the past five years.

## **Gun Violence Prevention and Mental Health Advocacy**

AAUW is a member of the newly formed Alliance for Gun Violence Solutions, a group of individuals who are deeply concerned about the heavy burdens gun deaths and injuries impose on our communities, families, workplaces, and schools. We are looking at the alarming statistics and the legislative policies needed to address the economic, mental, and physical difficulties for survivors and the impact on state resources. Gov. Michelle Lujan Grisham included some of these statistics in her proclamation declaring June 2023 Gun AwarenessMonth:<u>https://www.nmhealth.org/publication/view/general/8304/</u>

This spring, AAUW helped to advocate successfully for the passage of the **Bennie Hargrove Gun Safety Act sponsored by Representative Pamelya Herndon**, my esteemed predecessor as AAUW State Public Policy Chair. Sadly since the law requiring safe storage and imposing criminal penalties went into effect, there have been quite a few gun deaths of children. She wants to conduct town halls around the state to increase public awareness of the issues and compliance with the law. The Alliance is planning a town hall in mid-

October in Santa Fe. Please contact her directly at pamelya.herndon@nmlegis.gov to help to arrange a town hall in your community.

Please ask your representative and senator to support gun legislation in 2024 and subsequent sessions. It will take years to overcome pro-gun lobbyists and the industry. There is a lot of misinformation to dispel along with providing the facts about gun violence and the associated costs. Few people realize that 63% of gun deaths in New Mexico are suicides, for instance. Incidental deaths of innocent victims have increased tremendously in the past few years. Homicides are happening almost daily.

**Data shows** that gun deaths will decrease if our state can delay by even seven days the date between an attempted purchase and possession by individual approved in accordance with our laws regarding background checks. Contrast New Mexico's gun laws with those in California, Colorado, Connecticut, and elsewhere.

## **Modernizing the Legislature**

AAUW continues to work in a very committed coalition to improve our legislature. Efforts to pass two constitutional amendments in the 2023 legislative session failed will proceed in slightly different form in the 2024 session. The goal is to get these amendments on the 2024 General Election ballot for voters to approve. One constitutional amendment will propose to increase the length of sessions to 60 days every year; the other constitutional amendment will proposes to create a commission to determine fair legislative salaries. New Mexico is the only state that does not pay its legislators. It's possible that voters could approve increasing session length and not approve paying legislators in the future. If voters approve having the Ethics Commission or another group determine salaries, legislation would need to pass in 2025 and be signed in order for legislators to receive pay in 2025 or later. Meanwhile the Legislative Council Services is considering other ways to provide some staff support and perhaps district offices for legislators. The coalition is working on additional ways to improve efficiency, quality, and transparency in our legislature. Common Cause is currently managing the coalition. Other members include the League of Women Voters of New Mexico, 350.org, Ethics Watch, New Mexico First, the Center for Civic Policy, and others.

# Paid Family & Medical Leave

Southwest Women's Law continues to lead a coalition to ensure economic security for New Mexicans. This legislative session we will try again to pass the Paid Family & Medical Leave Act (PFMLA). Legislative sponsors and advocates have had promising signs from the governor that she will put this legislation on her call for the short session. The legislation proposes the creation of a program, administered by the state of New Mexico, to provide up to 12 weeks of paid leave for eligible employees to care for a new child, a family member with a serious health concern, or their own medical condition. The act would establish the Paid Family & Medical Leave Fund, administered by the New Mexico Department of Workforce Solutions (NMDWS). Individuals who need to take a longer period of time away from work to manage certain kinds of medical and family issues could apply to NMDWS to receive a percentage of their salary. The Fund would be paid for through employee and employer contributions. For every \$1000 earned, a worker will pay \$5 into the PFML Fund. For a full-time minimum wage employee, that will be about \$2.30 per week. Employers with more than five employees would add \$4 to the Fund. Employers with fewer than five employees will not be required to pay into the PFML fund. PFML will be especially helpful for small businesses that don't have the resources to provide paid leave to employees who may need to take up to 12 weeks away from work due to specific life events. With PFML an employee approved for leave receives funds from NMDWS, so the employer can use the savings to pay overtime, hire a temps, or reinvest in their business.
