From our Presidents

Greetings to all our New Mexico Branches and Members.

We are beginning a new 2024-2025 year with an experienced Co-President – Helena Whyte and a new one – Anne Chase, who have been attending monthly AAUW Governance Committee Zoom meetings.

As you plan your new branch year, evaluate what your branch has outgrown and may need to update/replace. Is there something that could be changed or added to your branch? Does your Branch web page need updating? Do you have a recent posting on your Branch facebook page?

This is our first year under our new By-laws (smaller leadership team), which means that we will have 3 LTM meetings this year - one of which will be via Zoom Nov 2, an in-person meeting in Santa Fe during the 60 day legislature session, and an in person state convention in April or May. Since the program chair is now a one-year appointed position, we are looking for a volunteer or committee to plan the state convention. Let Helena or Anne know if you would like to find the state convention location. Kathy Davis, Cheri Burch and Sylvia Fink planned the

2024 convention in Alamagordo even though we did not have a branch there (we may have a new branch forming there).

As everyone is well aware, this November is a big election and one of our priorities is to get out the vote. Because New Mexico has early voting, we need to start now to encourage all our members to exercise their right to vote – both up and down the ballot.

We encourage you to think critically about your civic responsibility and to examine the issues before casting your vote. AAUW is a nonpartisan organization which means you cannot use AAUW affiliation if you are working for a specific candidate. You can speak out about the issues, but you cannot use AAUW name to support a political party.

The UN is calling 2024 a "Super Year" because internationally 3.7 billion voters will be going to the polls in 72 countries, making this the largest election year in history!

We also want to congratulate the Carlsbad Branch on signing up 25 new members at their Champagne en Blanc event! VERY impressive!

Public Policy Report Meredith Machen, Public Policy Chair

It's My Vote- AAUW's 2024 Election Guidelines



AAUW's State Public Policy Chairs have been asked by national to make sure that members are clear about our nonpartisan policies, which are stricter than some other nonprofit organizations. In broad strokes, AAUW never expressly advocates for the election or defeat of any clearly identified partisan candidate or political party and never prepares for or coordinates election-related activities with any candidate or political party. It's a bit more complex than that. There are certain AAUW policies prohibiting 501(c)(3) organizations from undertaking activities that are legally permissible for 501(c)(4) organizations. We summarize the difference by saying that 501(c)(3) nonprofit organizations are able to accept tax-deductible donations and are primarily educational entities whose advocacy activities are limited, but when it comes to elections, the distinctions in status matter.

AAUW's Action Fund (501(c)(4) has a 2024 Voter Guide template useful for us when determining where candidates stand on our priority issues. See https://www.aauwaction.org/voter-education/voter-guides/.

Several of our national Public Policy meetings and special election trainings have focused on subtleties that I will summarize here. Comments and queries from my counterparts in other states make me appreciate once again how enlightened New Mexico's laws and policies are in terms of human rights, education, social services, health care (including reproductive rights, gender equity, and other areas. We are making progress as a state, though we lack sufficient funding and infrastructure to address our most intractable problems.

As is clear in AAUW-NM's newly revised bylaws, our state organization is a 501(c)(4) nonprofit organization. AAUW-NM's Advocacy Team, which operates under 501(c)(4) rules, conducts activities to promote policies, programs, and funding at the legislature and other state and local governments, including school boards. While a couple of our branches are separately incorporated as 501(c)(3) organizations, most branches have 501(c)(4) status. AAUW is adamant that whether organized under 501(c)(3) or (c)(4) we are never allowed to support candidates or parties. In this election cycle, we are seeing other nonprofits organized under 501(c)(4) rules using their action funds to support and/or oppose specific candidates. The stakes are very high this election and speaking out on issues of importance is our right as Americans; however, we must do so carefully. I believe that some of our usual allied organizations, respected nonprofits, which share our priorities, could be on very thin legal ice that could jeopardize their status with the IRS. We will abide by longstanding AAUW policies and procedures. We can compare candidates' positions, statements, records on voting on or promoting legislation, as long as we do our analyses fairly and equally, side by side. **Individual AAUW members** may endorse candidates for partisan elective office, contribute money or anything of value to such candidate(s), and organize for supporting such candidate(s) as long as there is no mention of AAUW "Any AAUW member who is actively involved in a candidate's campaign should avoid participating in activities that may give the appearance of AAUW's endorsement of the candidate."*

"Election activities carried out in AAUW's name must be conducted within the guidelines set out in AAUW policies. Activities must also be allowable under regulations established by the U.S. Internal Revenue Service and the Federal Election Commission. There are certain AAUW policies prohibiting 501(c)(3) organizations from undertaking some activities that are legally permissible for 501(c)(4) organizations.

WHAT AAUW ORGANIZATIONS MAY and MAY NOT DO

Focus issue education messages and get-out-the-vote activities on the impact that the election results will have on AAUW priority issues.

Those messages or activities **must not** expressly advocate the election or defeat of any candidate or party. Encourage voters to support unspecified candidates who agree with AAUW's position on specific issues. For example, a branch or state can publish a "vote prochoice" message. The message cannot appear, however, in a publication that gives candidates' views on reproductive rights. Identify particular groups in the community (e.g., women, people of color, people with disabilities) to be part of coalition efforts or to receive election materials. Decisions about which groups to work with should be based on factors such as the desire to build a broad-based coalition, not on whether an anticipated coalition member can affect the outcome of an election. Any political action committee or organization that has endorsed a candidate cannot be asked to be a coalition member in an AAUW voter education or voter turnout campaign.

VOTER EDUCATION

"Any publication or oral statement of the candidates' responses to questions asked on a questionnaire or at a forum may include a statement of AAUW's position on the issues covered, as long as there is no call to remember AAUW's position when voting."

In addition to voting records, the following may be used to gather and publicize information about the candidates' positions on issues: position papers issued by candidates, public statements made by candidates, candidate questionnaires, and candidate forums. Different guidelines apply to each activity.

All candidates running for the offices to be covered in the questionnaire must have the opportunity to participate. Language must not favor or disfavor a particular candidate, and all responses received must be printed in their entirety in any publication of questionnaire responses. The publication of responses should include the names of all candidates to whom the questionnaire was sent, but publication may proceed even if all candidates do not respond.

FORUMS

All major party candidates for the office must be invited, and an effort must be made to ensure their participation. **If only one candidate can attend and the other candidates do not send**

representatives, AAUW branches with 501(c)(3) status may not proceed with a forum. AAUW branches with 501(c)(4) status may proceed in organizing regardless of how many candidates attend."

*Quotations are excerpts from **AAUW Board of Directors Policy Book, May 2024, which** *is* available online. Segments have been re-arranged for clarity. Policy 301 in the Policy Book has the full set of rules for AAUW's 501(c)(4) nonprofit organizations for our state entity. Any entity that has not filed to be separately incorporated as a 501(c)(3) organization falls under AAUW's 501(c)(4) status.

October 22-Last day to request absentee ballot/vote-by-mail application November 5 – Election Day. Mail-in ballots must be received by your county clerk by 7pm Close to deadline? Deliver to your county clerk or use drop-boxes. Expect mail delivery to be very slow.

AAUW Carlsbad met in July to plan our events for the year. We had a good turnout at the meeting and set some exciting events.

We already had a successful start by bringing back the Champagne Brunch en Blanc. We held this event back in 2018 and 2019. This year we were fortune to have it again. It was held on Sunday, August 25 at The Valley Venue. The Valley Venue is a new wedding venue owned by

our Program Chair and she very generously let us have the event there.

We asked for nominations for our AAUW Carlsbad Empowerment Award, given to a woman who has done work to empower women in the community. We received 8 nominations and the award went to Zelma Lopez, the Executive Director of Affirming Heart Victim Services. The last general meeting of the year in May was a garden luncheon at the home of Janet Matwiyoff, where members socialized and welcomed new members and visitors.

The first meeting of the 2024-25 year in September featured a jigsaw puzzle competition, which even drew the attention of some residents of the retirement community where meetings are held. STEM chair Cheri Burch gave a short presentation about the history of jigsaw puzzles, as well as the benefits to doing puzzles. Attendees were split into teams of four, each with the same (science themed!) puzzle to do within 45 minutes, and only allowed to see the image at the beginning of the time. The winning team, completing the puzzle in just under 28 minutes, included branch members Mary Moskal, Kim Scheerer, Sue Phelps, and guest Trish Merewether.
